University of Florida – Transfer Admission Process

Why are you applying to University of Florida (UF):

• Per our partnership with UF to award baccalaureate degrees to our students, you must be enrolled as a student at UF. This process is to get you admitted and into the UF system.

Preferred application deadline: May 31st.

• This date gives you time to work through any possible issues and still meet the July 15th deadline.

Materials / info to have:

- Electronic, unofficial transcripts.
 - Login to your MDConnect portal for MDC transcript. Instructions are here: <u>https://www.mdc.edu/transcripts/unofficial.aspx</u>
 - Any copies of external exams (AP, IB, CLEP, SAT, etc.) are also useful.
 - Official transcripts (high school, college, exams, etc.) will be requested and/or sent by student later.
- Gather any documents (at least two) needed to prove Florida residency fortuition purposes, such as **electronic copies** of your parent's driver's license and voter's registration card. You'll want to upload the copies during the admissions process. More information is located here: <u>https://admissions.ufl.edu/cost-and-</u> aid/residency
- Know your own citizenship status
- A quick, 200-word statement on what skills / values you hope to obtain by completing your degree in chosen major, and how do you plan to apply those. A good idea is to use your prior NWSA application statement, if you still have it.

Quick tips:

- You may save the application as you progress. You can exit and enter the application later.
- The application will NOT allow you to move forward with next portions of the application until all areas of the current section have been completed.
- There are notes highlighted on each page of the file to help guide you through the application.

What happens after you submit the application?

- Watch your email! You'll be notified about the status of your application by UF directly.
- Review the transfer admission checklist at_ <u>https://admissions.ufl.edu/apply/transfer/after-being-admitted</u>. Of course, not all options (such as housing, immunization or transfer orientation) may pertain to you, but if is helpful with the following:
 - Creating your GatorLink credentials and account.
 - NWSA will request your GatorOne card at a later date.
 - Sending any AP, IB, AICE, or other external test scores.
 - Sending your high school transcript and any prior transcripts from other
 - o colleges and universities to UF
 - Remember dual enrollment credits, while on your high school transcript, must be requested from the college / university offering the course(s).
- Inform your Advisor or Director of Student Services that you've completed the application.
 - If applicable, we will request your that your electronic MDC transcript to be released to UF.
 - Note: This is a special request only between MDC and UF during this transfer admission process. Transcript requests to / from other institutions must be done by the student.
 - There are times when UF may request a paper transcript, and this may need to be requested by the student.
- Remember this process is to get you into UF's system. You may be required to complete a transient application later, and if so, we'll explain the process to you.

- International Students: Depending on whether you'll need to be a transient student first, you may not need to transfer your paperwork immediately. > A Florida "resident for tuition purposes" is a person who has, or a dependent person whose parent or legal guardian has, established and maintained legal residency in Florida for at least twelve (12) consecutive months preceding the first day of classes of the term for which Florida residency is sought. Residence in Florida must be a bona fide domicile rather than for the purpose of maintaining a residence incident to enrollment at an institution of higher education. To qualify as a Florida resident for tuition purposes, you must be a U.S. citizen, a foreign national in a nonimmigrant visa classification that grants you the legal ability to establish a bona fide domicile in the United States, a permanent resident alien, parolee, asylee, Cuban-Haitian entrant, or legal alien granted indefinite stay by the U.S. Citizenship and Immigration Services. Other persons not meeting the twelve-month legal residence requirements may be classified as Florida residents for tuition purposes only if they fall within one of the limited special categories authorized by the Florida Legislature pursuant to section 1009.21, Florida Statutes. All other persons are ineligible for classification as a Florida "resident for tuition purposes."

Living in or attending school in Florida will not, in itself, establish legal residence. Students who depend upon out-of-state parents for support are presumed to be legal residents of the same state as their parents. Residency for tuition purposes requires the establishment of legal ties to the state of Florida. A student must verify that the student has broken ties to other states if the student or, in the case of a dependent student, his or her parent has moved from another state.

Qualification by Exception

If you do not meet the above criteria, you may qualify for residency based on an exception. Please check if one or more applies.

(A) I am a **qualified beneficiary** under the terms of the Florida Prepaid College Program (s. 1009.98, Florida Statutes.) (Required: Copy of Florida Prepaid Recipient card)

- (B) I am married to a person who has maintained legal residence in Florida for at least the past 12 consecutive months. I now have established legal residence and intend to make Florida my permanent home. (Required: Copy of marriage certificate and/or other documents required to establish residency.)
- (C) I was previously enrolled at a Florida state postsecondary institution and classified as a Florida resident for tuition purposes. I am transferring to another Florida state postsecondary institution within 12 months of the previous enrollment.
- (D) I was previously enrolled at a Florida state postsecondary institution and classified as a Florida resident for tuition purposes. I abandoned my Florida domicile less than 12 months ago and am now re-establishing Florida legal residence.
- (E) Active duty members of the Armed Services of the United States residing in this state and their spouses and dependent children, and active drilling members of the Florida National Guard. (Required: Copy of military orders or DD2058 showing home of record)

(F) Active duty members of the Armed Services of the United States and their spouses and dependents attending a Florida College System institution or state university within 50 miles of the military establishment of military orders)
(G) United States citizens living on the lsthmus of Panama who have completed 12 consecutive months of college work at the Florida State University Panama Canal Branch, and their spouses and dependent children. (Required: Copy of marriage certificate or proof of dependency.)
(H) Full-time instructional and administrative personnel employed by the State of Florida public schools and institutions of higher education and their spouses and dependent children. (Required: Employment verification).
(I) Students from Latin America and the Caribbean who receive scholarships from the federal or state government. Any student classified pursuant to this paragraph shall attend, on a full-time basis, a Florida institution of higher education. (Required: Proof of scholarship and Latin America or Caribbean residency)
(J) Southern Regional Education Board's Academic Common Market graduate students attending Florida's state universities. (Required: Certification letter from State Academic Common Market Coordinator)
(K) Full-time employees of state agencies or political subdivisions of the state when the student fees are paid by the state agency or political subdivision for the purpose of job-related law enforcement or corrections training. (Required: Employment verification/payment agreement)
(L) McKnight Doctoral Fellows and Finalists who are United States citizens. (Required: Verification from graduate studies)
(M) United States citizens living outside the United States who are teaching at a Department of Defense Dependent School or in an American International School and who enroll in a graduate level education program that leads to a Florida teaching certificate. (Required: Proof of enrollment in graduate program for FL teaching certificate)
(N) Active duty members of the Canadian military residing or stationed in this state under the North American Air Defense (NORAD) agreement, and their spouses and dependent children, attending a Florida College System institution or state university within 50 miles of the military establishment where they are stationed. (Required: Proof of active duty membership for specified purpose)
(O) Active duty members of a foreign nation's military who are serving as liaison officers and are residing or stationed in this state, and their spouses and dependent children, attending a Florida College System or state university within 50 miles of the military establishment where the foreign liaison officer is stationed. (Required: Proof of active duty membership for specified purpose)

1009.21(1)(f), Florida Statutes, (i.e., either or both parents of the student, any guardian of a student, or any person in a parental relationship to the student). My parent has maintained legal residence in Florida for at least the past 12 consecutive months. As defined by *section 1009.21(1)(d), Florida Statutes*, "legal resident' or 'resident' means a person who has maintained his or her residence in this state for the preceding year, has purchased a home which is occupied by him or her as his or her residence, or has established a domicile in this state pursuant to s. 222.17." If you are a dependent student then a copy of your parent's tax return may be requested to establish dependence.

An *independent student*, as defined by s. 1009.21(1)(a), Florida Statutes, is someone who has maintained legal residence in Florida for at least the past 12 consecutive months and provides more than 50% of their own support. An independent student generally includes a person who is at least 24 years old, married, a graduate or professional student, a veteran, a member of the armed forces, a ward of the court, or someone with legal dependents other than a spouse, pursuant to the United States Department of Education for the purposes of federal financial aid eligibility. There may be limited cases where a person under the age of 24 years old may qualify as an independent student. Such students will be required to verify independence (including financial independence.) If you are an independent student then a copy your tax return may be requested to establish independence.

As provided in s. 1009.21, Florida Statutes, I meet residency requirements by one of the previous qualifications by exceptions.
